**Paris, France, April 8, 2021** - HealthTech Innovation Days (HTID®) has become the reference event for European innovative healthcare companies that want to accelerate their development through funding and partnerships with industry in the field, in order to promote access to healthcare for all. **This forum promoting collaborations within the international healthcare ecosystem announces the opening of applications for European innovative healthcare companies from Monday, 12 April 2021.**

- **Digital Health** product developed or under development with partners (hospitals, pharmas or industrials companies)
